**Recommendation:**

Direct Staff to proceed with the analysis phase of a proposed annexation of the Forestville Fire Protection District in preparation for executing a Concurrent Resolution for Annexation in August.

**Financial Impact:**

**Background:**

The Forestville Fire Protection District Board of Directors voted unanimously at its meeting on May 12, 2020, to request that the Sonoma County Fire District proceed with annexation of the FFPD and set an agenda topic for their August Board meeting to consider adoption of a concurrent resolution for annexation. The proposed timeline involves beginning the LAFCO application for reorganization process in September of 2020 with a projected annexation "go live" date of July, 2021.

**RE: Consolidation Ad-Hoc Committee Discussion Item #1**

The focus of the Consolidation Ad-Hoc Committee is to evaluate viable options, to be presented to the Board of Directors, on securing a future plan for the Forestville Fire Protection District that will provide the best level of service to the citizens of our community at the lowest possible cost to our taxpayers.

## Our Current Situation

- Chief Dave Franceschi will retire June 30<sup>th</sup>, 2021.
- Assistant Chief John Franceschi does not desire to assume the role of Fire Chief.
- Forestville Station is currently staffed with 2 fulltime personnel and 1 volunteer/stipend.
- Firefighter staffing is getting difficult to fill; 7 days open in April and 5 days open in May.
- County Tax Measure G did not pass in March of 2020.
- Current call response is averaged at 2.35 volunteer firefighters per call.

**In order to provide the residents of Forestville a level of service that would sustain a Department Chief, Battalion Chief coverage for all shifts and a minimum staffing level of three full time firefighters on our first out engine, it would require:**

- Total for 3 firefighter/EMT's: \$343,122.87\*
- Total for 3 Battalion Chief's: \$675,607.58\* (In addition to being on shift BC's would each be assigned an area of responsibility: Prevention, Training & Facilities)
- Total Fire Chief additional cost: \$51,457.82\* (This is the cost difference between the current Chief salary and what we would need to pay for market rate competitiveness.)
- Total Cost for 3 FF/EMT's, 3 Battalion Chief's and 1 Fire Chief: \$1,070,188.27\*

(\*Includes base salary, FLSA (Chief doesn't get FLSA), Workers Compensation, FICA, Unemployment, CalPers, Medical, Dental, Vision and Overtime calculated off past data.)

We receive \$351,875 annually with our current \$115.00 parcel tax. To obtain the above level of service, we need an additional \$1,070,188.27 dollars annually.

To obtain this level of service for the District, we need to ask the voters for \$350.00 per parcel in addition to our current \$115.00 per parcel, for a total of \$465.00 for **every** parcel (vacant, residential, agricultural & commercial). We would also need to include a cost of living adjustment (COLA) to keep up with the increasing costs of service.

Please also note that if Forestville Fire Protection District wants to achieve its goal of a paramedic on the engine in the future, then an internal program will need to be implemented which would possibly require another tax increase to the citizens.

### **Neighboring Parcel Tax Comparison**

#### Graton Fire

- Plan to hire 3 Engineers and 3 Firefighters
- Generates \$800,000 annually

#### Occidental Fire

- 2019 Parcel Tax
  - Residential \$200.00 per house, \$100.00 per additional unit
  - Hotel/Motel/Camp \$300.00 per parcel, \$50.00 per room/site
  - Commercial/Industrial \$300.00 per parcel plus \$.14 per square foot
  - Other \$100.00 per parcel
- Plan to hire a daytime stipend firefighter
- Generates \$250,000 annually

#### Forestville Fire

- 1982 Parcel Tax
  - Unimproved parcel \$10.00 per acre, up to 4 acres max
  - Residential \$40.00 per house, \$40.00 per additional unit
  - Commercial \$100.00 per parcel
  - Industrial \$200.00 per parcel
  - Farmland \$40.00 per parcel
  - Mobile Home \$20.00 per unit
  - Generates \$147,950 annually

## Our Current Situation

## Sonoma County Fire District - Consolidation as a Plan

I have spoken to Chief Heine on numerous occasions recently and he is still very much open to a consolidation with Forestville Fire. There are no hard feelings at all, and he has reiterated to me his respect for our Board of Directors, staff and District. I have also learned that it is now very likely that Sonoma County Fire will take over the ambulance contract in the near future which would bring an additional several million dollars to their Districts bottom line.

As a reminder consolidation with the Sonoma County Fire District would provide Forestville:

- 3-0 fulltime staffing for Forestville Fire - 1 Captain, 1 Engineer, 1 Firefighter;
- Shift Battalion Chief Coverage – A, B, C Shift;
- Fire Prevention Bureau- 1 Battalion Chief, 1 Captain, 1 Inspector;
- Training Bureau;
- Full Administrative Support staff;
- The opportunity for paramedics on each engine (this could only be achieved through a consolidation unless Forestville Fire created their own Paramedic program).

I would also like to clarify a few additional points/concerns that were raised in the past:

- Sonoma County Fire District has said they will not close Forestville Fire Station.
- Forestville citizens need emergency services available at the Forestville Fire Station.
- The Sonoma County Fire District is a special district that is governed by a 5 person Board of Directors. There are 4 seats up for re-election November 2020. Starting 2022 they will move to District Elections. The seats will be designated by the County Elections Officer based on the results of the 2020 Census. The Russian River area will get one seat at that time, if Forestville Fire ends up consolidating also, then it is likely that one seat will be assigned to both areas, again, that will be up to the Elections Officer.
- Sonoma County Fire District currently has 5 staffed fire stations with 3 full time personnel at each location. Russian River will be the 6<sup>th</sup> staffed fire station as of July 1, 2020.
- A 2000 square foot home in the Sonoma County Fire District pays approximately \$190.00 per year for their parcel tax.

If the Board wishes to pursue a consolidation the timeline would look like this:

**A RESOLUTION OF THE GOVERNING BOARD OF THE SONOMA COUNTY FIRE DISTRICT, COUNTY OF SONOMA, STATE OF CALIFORNIA, DECLARING WEEDS AND RUBBISH UPON OR IN FRONT OF CERTAIN PROPERTIES WITHIN THE SONOMA COUNTY FIRE DISTRICT TO BE A PUBLIC NUISANCE; AND DIRECTING THE SONOMA COUNTY FIRE DISTRICT TO GIVE NOTICE THEREOF PURSUANT TO SECTION 14892 OF THE HEALTH AND SAFETY CODE**

**WHEREAS**, it is the determination of the Board of Directors of the Sonoma County Fire District that certain weeds growing upon the streets and sidewalks and upon or in front of private property within the Sonoma County Fire District which bear seeds of a wingy or downy nature, and other weeds which have attained or will attain a full, natural growth in height in excess of four inches, and vines which are closer than twenty feet to any combustible building, fence or other combustible improvements whatsoever, are noxious and dangerous, and that the same constitute a public nuisance; and

**WHEREAS**, It is the further determination of the Board of Directors of the Sonoma County Fire District that rubbish consisting of all combustible or noncombustible waste, refuse and worthless or useless articles of property left, deposited or abandoned on those parcels within the Sonoma County Fire District in Exhibit "A" (attached) in such fashion and in such quantity as to be unhealthful, dangerous to persons, or so as to interfere with the abatement of weeds under this article, be and the same are hereby declared to constitute a public nuisance;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Sonoma County Fire District that such weeds and rubbish as herein above described now growing or situated upon the streets or sidewalks or upon or in front of private property within the Sonoma County Fire District and identified in Exhibit "A" (attached) constitute and are hereby declared to be a public nuisance; and

**BE IT FURTHER RESOLVED** that the Sonoma County Fire District is hereby authorized to give notice directing the abatement of such nuisances in accordance with the provisions of Section 14892 of the Health and Safety Code, which notice shall contain the time and place for hearing objections as herein set forth.

## SIDE LETTER TO MEMORANDUM OF UNDERSTANDING

Whereas, the Sonoma County Fire District ("SCFD") and the International Association of Firefighters, Local 1401, Sonoma County Professional Firefighters ("L1401") are parties to a Memorandum of Understanding schedule to expire on June 30, 2021; and

Whereas, SCFD and L1401 has agreed to the following, without prejudice to its position and without waiving any rights, including but not limited to the law, MMB, the MOU:

1. Add the following language to ensure compliance with Cal PERS requirement regarding premium pay items:

*3.7 Premium Pay SCFD MOU 2019- Current*

*3.8 in RV MOU 2015-2019*

*II-6 WF MOU 2015-2019*

*Working out of Classification is defined as compensation within the meaning of Section 20636 of the California Government Codes and Section 571(a)(1) of the PERS Regulations. If an employee performs temporary duty in a classification higher than his/her own, he/she shall receive **additional pay in the amount of five (5) percent of his/her hourly rate of pay for each hour worked in a higher classification. This pay category is noted as premium pay. The employee's hourly rate is calculated using their base rate and all applicable incentives.***

*The language complies with California Code of Regulations (CCR) 571(b)(1)(B).*

*CCR 571(b)(1)(B) states:*

*(b) The Board has determined that all items of special compensation listed in subsection (a) are:*

*(1) Contained in a written labor policy or agreement as defined at Government Code section 20049, provided that the document:*

*(B) Indicates the conditions for payment of the item of special compensation, including, but not limited to, eligibility for, and amount of, the special compensation.*

2. Add the position classification of Firefighter/Paramedic to the positions represented by L1401.
3. Establish a base pay for the position of Firefighter/Paramedic that is 10% above the base pay for the position of Firefighter/EMT.
4. Add the position classification of Captain/Deputy Fire Marshal to the positions represented by L1401.
5. Add the following language for the position of Captain/Deputy Fire Marshal:

“The Deputy Fire Marshall when assigned to a shared on-call position as a fire investigator on their routine day off, shall receive a daily stipend of \$125. Any hours worked if deployed, shall be compensated at their OT rate for the hours worked and shall be paid “portal to portal”. The on-call schedule shall be set by the Battalion Chief/Fire Marshall.”
